ORDINANCE 5-2020

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH STATE OF NEW JERSEY AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATIONS LIMIT AND ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14) FOR CALENDAR YEAR 2020

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Wall in the County of Monmouth finds it advisable and necessary to increase its CY 2020 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, fiscal responsibility, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 1.0% increase in the budget for said year, amounting to \$333,791.39 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriations in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Wall, in the County of County of Monmouth, with a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2020 budget year, the final appropriations of the Township of Wall shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$1,168,269.87 and that the CY 2020 municipal budget for the Township of Wall be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

This Ordinance shall take effect upon its passage and publication according to law.

**AUTHORIZATION AND DIRECTION FOR THE TAX COLLECTOR TO
EXTEND THE SECOND QUARTER 2020 GRACE PERIOD**

WHEREAS, in an attempt to alleviate some of the financial burden on property taxpayers during the COVID-19 State of Emergency and Public Health Emergency crisis, Governor Philip D. Murphy executed Executive Order No. 130 on April 28, 2020, which authorizes municipalities to adopt a Resolution to extend the grace period associated with the second quarter 2020 tax payment, which is due as of May 1, 2020, to a date no later than June 1, 2020; and

WHEREAS, the Mayor and Committee of the Township of Wall are extremely sensitive to the financial hardships that are being suffered by many property taxpayers during the current time, and wish to extend the grace period associated with the second quarter 2020 tax payments until June 1, 2020, in accordance with the authorization provided by Executive Order No. 130; and

WHEREAS, upon passage of this Resolution, the due date for the second quarter 2020 property tax payments shall remain as May 1, 2020, but the grace period associated with making said payments shall be extended to June 1, 2020, after which time interest shall accrue dating back to May 1, 2020 (and shall be calculated in accordance with the interest rates previously set by the Township).

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Wall, that the Tax Collector is hereby authorized and directed to extend the grace period associated with the second quarter 2020 property tax payments to June 1, 2020, after which time interest shall accrue dating back to May 1, 2020 (and shall be calculated in accordance with the interest rates previously set by the Township).

AUTHORIZATION FOR THE TAX COLLECTOR TO PREPARE AND ISSUE ESTIMATED TAX BILLS FOR THE THIRD INSTALLMENT OF 2020 TAXES

WHEREAS, the Monmouth County Board of Taxation has not certified a tax rate for all of the taxing entities covered in the municipal property tax bill and the Township of Wall Tax Collector will be unable to mail the Township's 2020 tax bills on a timely basis; and

WHEREAS, the Township of Wall Tax Collector in consultation with the Township of Wall Chief Financial Officer has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and they have both signed a certification showing the tax levies for the previous year, the tax rates and the range of permitted estimated tax levies; and

WHEREAS, the estimated tax bills will enable the Township to meet its financial obligations, maintain the tax collection rate, provide uniformity for tax payments and save the unnecessary cost of interest on borrowing.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey on this 13th day of May 2020 as follows:

1. The Township of Wall Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the Township for the Third Installment of 2020 taxes. The Tax Collector shall take such actions as are permitted and required by P.L. 1994, c. 72 (N.J.S.A. 54:4-66.2 and 54:4-66.3).
2. The entire estimated tax levy for 2020 is hereby set at \$118,632,273.16.
3. In accordance with law, the Third Installment of 2011 taxes shall not be subject to interest until the later of August 10th or the twenty-fifth calendar day after the date the estimated tax bills were mailed. The estimated tax bills shall contain a notice specifying the date on which interest may begin to accrue.
