Message from the Township Committee

The Township Committee would like to update the residents and businesses of Wall Township on some of the issues that are affecting our community. Our Newsletter provides a valuable resource to our taxpayers on programs, upcoming events and services provided by Wall Township. We are proud to serve as your elected officials representing you on various issues affecting our community, and we are also proud of the job our municipal employees do in performing their daily functions for the residents of our Township.

Preparing and implementing the annual municipal budget is one of the primary functions we perform as your elected officials. Providing municipal services at a cost we can afford is a primary goal of the Township Committee. While your tax dollars for municipal services represent only 18% of your taxes, they are used for providing a great many services for our residents and businesses. The public safety portion of the municipal budget goes toward providing 24-hour police services and EMS services during daytime hours in Wall Township. Department continues to be one of the best in the State of New Jersey and the men and women in our public safety department work around the clock to assure the safety of our residents throughout the year.

Our Public Works Department is the second-largest department in municipal government and provides twice weekly trash collection, monthly bulk and recycling collection, along with leaf,

brush and road maintenance.

The Township's Recreation Department is busy establishing programs for youths and adults throughout the Township. It provides educational, recreational and athletic programs throughout the year. Seasonal events, such as our fire works and Volunteer Day, are also part of our recreation program in the Township.

D.A.R.E. Graduation Set for May 10

The Wall Township Police Department will hold the graduation for the township's D.A.R.E. students on May 10 at the Oak Tree Lodge.

D.A.R.E. officer Ptl. Mike Tozer said the D.A.R.E. program has been successful in large part due to the support of local businesses that help make D.A.R.E. activities and programs over the year possible and the support of Police Chief Roy Hall.

This year, the D.A.R.E. program is graduating 336 students.

"D.A.R.E. helps to put a face to a uniform," says Ptl. Tozer, one of the police department's four D.A.R.E. officers. "It lets the kids know they have someone out there they can trust and that they can turn to if they need help.

"We also educate our students to the dangers and the problems they can face if they use drugs."

The graduation/culmination that starts at 10:30 a.m. and runs through 2:00 p.m. will be a day of activities and fun. The activities planned include a football-throwing contest and a tug-of-war competition between D.A.R.E. classes. A clown and a magician will be on hand to entertain. Police Department vehicles will be on display.

Community and local business supporters for D.A.R.E. programs and the graduation include Oak Tree Lodge owner Pete DeCuir, who is donating the use of the lodge for the day. Bill Panagakos, the manager of Firestone Tires, Route 35, held a two-day tire sale on April 11 and 12 during which he made a \$5 contribution to the D.A.R.E. program for each tire sold.

WALL PUBLIC LIBRARY:

Then...

“To celebrate the accomplishments of today, one must reflect on the vision of the past.”



On February 23, 1961,

a group of five trustees from the Friends of the Wall High School Library - Leonora Cole, Evelyn Heroy, Dorothy King, Audrey Shefter and Dorothy Treney - along with Mayor Richard Sharpe and Superintendent of Schools, Granville Magee, formed the new Wall Public Library Association. With donated books left from the book drive for the Wall High School Library, a borrowed room in the Little Red Schoolhouse (now blue) and a great deal of determination, they met with the Wall Township Committee and Miss Julia Killian, Monmouth County Library Director, and persuaded the committee to allocate \$3,000 of public funds toward the establishment of a public library. Miss Killian pledged a collection of County-owned books to supplement books already owned by the Association.

On March 16, 1961, the group approved and adopted a constitution and by-laws. The first officers were elected:

President - Mrs. Guy Treney

Vice-President - Mrs. Robert Heroy

Recording Secretary - Mrs. Robert Todd

Corresponding Secretary - Mrs. Charles Ostwald

Treasurer - Mrs. Sydney Shefter

Historian - Mrs. Stephen Blauvelt

Elected Trustees included Mrs. Treney, Mrs. Heroy and Mrs. M. Donald King, Mrs. Sydney Shefter, Mrs. Hubert Cole, Superintendent of Schools Mr. Magee and Township Committee member Mr. Stephen Blauvelt. For eight

weeks, fifteen members of the Wall Public Library Association took library training at the Monmouth County Library in Freehold, preparing to work in the library and assist with book processing. Meanwhile, other volunteers installed shelving and repainted the borrowed room.

The Wall Public Library was dedicated and officially opened on July 15, 1961. An open house was presided over by Mrs. Harry Murphy and Mrs. Charles Ostwald, co-chairmen. Mr. Edward Krayl, Wall Township Committeeman, cut the ribbon and balloons bearing the words “I have been to the Wall Public Library” were distributed to children. Staffed by volunteers, the library was open for ten hours per week and served 477 patrons. In August, the first paid library worker, Mrs. Albert Otto, was hired. By the end of the second year of operation, the library was open for sixteen hours per week, served **750 patrons** and circulated **7352 titles**.

Today, in a magnificent building of its own, Wall Public Library is a branch of the Monmouth County Library System. It is open for 53 hours per week, with a full-time Branch Librarian, Children’s Librarian, a staff of six, an active and hard-working Library Association, and a host of enthusiastic and dedicated volunteers. In 2002, the library served **15,309 patrons**, circulated more than **one-quarter million titles** and was voted “**One of the Best**” public libraries by the Asbury Park Press Reader’s Choice Poll for the **second year in a row**.

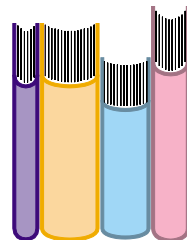

Summer Reading Program



During the summer, the Monmouth County Library System sponsors a Summer Reading Program. The program is divided into two reading clubs, the **Read-to-Me Club** and the **Vacation Reading Club**.

The Wall **Read-To-Me Club** is for children going into kindergarten and first grade who are not quite reading. This group has a party at the end of the summer to celebrate its members' accomplishments.

The **Vacation Reading Club** is available for any child who already is reading. It is a loosely structured club where children come into the library any time during normal library hours and report the books they have read. This read-

ing club encourages children to read whatever book they choose. Aside from experiencing the joy of reading, the children are developing good reading habits as well as polishing their reading skills. At the end of the summer, Wall Library provides a gigantic book bingo game on two different days to celebrate each child's accomplishment. Additionally, each child goes home with a paperback book. Parents and teachers both report that the reading program has encouraged many children on the road to reading. Children who have difficulty reading or who are not reading at the beginning of the summer often are reading with ease and enjoying it by the end of the summer.

Wall Community Relations/ Community Alliance Committee

The Wall Community Relations/Community Alliance Committee has been busy with numerous successful programs and events. We have been working hard to bring programs to our community's young people as well as the adults. We think we have provided a good balance of prevention, health and wellness programs and have even more things to come.

Recently, we sponsored Mr. Michael Pritchard as a motivational speaker at the High School. He spoke to students during the day and parents in the evening, delivering a powerful message of self-esteem, making good and bad choices, drugs, alcohol and bullying.

Last September, in cooperation with Dr. Tony Garrow and with the support of local businesses, the Alliance held "Kids Day America", our first-ever health and prevention fair. We hope to make this successful project an annual event and have scheduled this year's Kids Day America for September 20. If you would like to be involved please let us know.

The Alliance continues to provide BABES education to all 3rd graders in Wall Township. BABES is a puppet-based curriculum that provides children with healthy living skills and information needed for protection from alcohol and drugs. The Alliance also sponsors a poster contest in April for the 4th and 5th graders in Wall schools in recognition of April as Alcohol Awareness Month. The Alliance also will offer our young people a program of stress relief through art, as well as women's self-defense classes, infant and child CPR classes and a seniors' day to determine the effects of medication. Once again, the

Alliance is sponsoring Project Graduation to help Wall High School graduates celebrate their accomplishments in a safe and fun manner.

In March, the Alliance held a successful pancake breakfast fundraiser to help support our efforts.

The Community Relations/Community Alliance Committee offers assistance and guidance to citizens in Wall that may have neighborhood problems. The committee is dedicated to coordinating efforts to combat alcoholism and drug abuse through prevention, intervention and education and to assisting the community in any way it can be of help.

REMINDER...

All township residents using the Recycling Center will be asked for proof of residency, i.e. driver's license, tax bill, etc.

All cardboard is to be flattened.

Household bulk and waste must be separated due to recycling handling.

Empty propane tanks may be recycled provided control valve is removed.

BULK PICK UP DAYS

Each area of the Township will have one designated bulk pickup day on a Wednesday each month. This bulk pickup day will take place unless the date in question falls on a Township holiday as above. Your bulk pickup week for your particular pickup zone is shown on the attached map and chart. On your designated bulk pickup day, the Township will pick up household appliances. Also included is debris resulting from minor alterations to a private residence by the owner or tenant. This is not intended to include debris from alterations done by contractors. Place at curb prior to 5:30 AM on the day of your bulk pickup. As stated, bulk pickup will not be provided during holidays observed by the Township.

It should be noted that the Township does not provide curbside pickup of tires or cardboard or junk mail. The

items must be taken to the Atlantic Ave. Recycling Center. Please note, there is no fee for disposal of cardboard at the Recycling Center. Tires may be disposed of at the Recycling Center located at Tiltens Corner Road for a small fee. A fee is charged due to the fact that the Township must pay a premium to get rid of building materials (doors, windows, wood, paneling, etc.) and tires. DO NOT put materials out for bulk pickup until the Monday before your scheduled Wednesday pickup.

The purpose of household bulk pickup is for the convenience of Wall Township residents. All bulk items are picked up on a 10 item basis. Any questions regarding volume or quantity, please call the Department of Public Works, 732-449-2700, before items are placed at the curb.

RECYCLABLES - Use 32 GALLON TRASH CANS. PROPER LABELS MUST BE USED AND HAVE THEM FACING THE STREET.
Do NOT PUT OUT IN PLASTIC BAGS.

HOUSEHOLD TRASH - USE CANS NOT EXCEEDING 45 GALLON CAPACITY. LIMIT OF 6 RECEPTACLES PICKED UP AT ONE TIME.

MEDICAL WASTE AND NEEDLES - SHOULD BE STORED IN A BIO-SHARP CONTAINER OR SOME OTHER MEDICALLY APPROVED CONTAINER BEFORE BEING COLLECTED BY THE TOWNSHIP

Brush/Leaf Pickup Schedule

BRUSH

Brush will be picked up during your bulk/recycling pickup week. Please have brush out at the curb the weekend before your bulk week. DO NOT put it out any sooner. (SEE MAP FOR YOUR ZONE).

ZONE 1 – FIRST WEEK OF THE MONTH - BULK WEEK

West Belmar area. Shark River Manor area,
north of 18th Ave. to East of New Bedford Road.

ZONE 2 – SECOND WEEK OF THE MONTH - BULK WEEK

West of New Bedford Road, north of 18th Ave.,
to the Township boundaries.

ZONE 3 – THIRD WEEK OF THE MONTH - BULK WEEK

East of Route 35, south of 18th Ave. to the Township boundaries.

ZONE 4 – FOURTH WEEK OF THE MONTH - BULK WEEK

South of 18th Ave., West of Route 35 to the Township boundaries.

Brush will be picked up during your bulk week February through October. The brush shall be a maximum length of 4 feet placed at curbside in a neat and orderly fashion, *free from viney material and leaves. Ordinance 28-2001, 3.7-3 will be strictly enforced.

* Butt Ends Facing Street

LEAVES

Leaves will be picked up with vacuum-type machines **November** through **December** during the **Fall Season**, and **April 1st** through **May 15th** during the **Spring Season**. Leaves must be put to the curb neatly at the edge of the road not to be mixed with viney materials, twigs, and evergreen prunings.

Do not put the leaves in plastic bags as they will not be picked up.

GRASS

Grass clippings are accepted at the Tiltens Corner Road Recycling Center. There is NO pickup of grass.

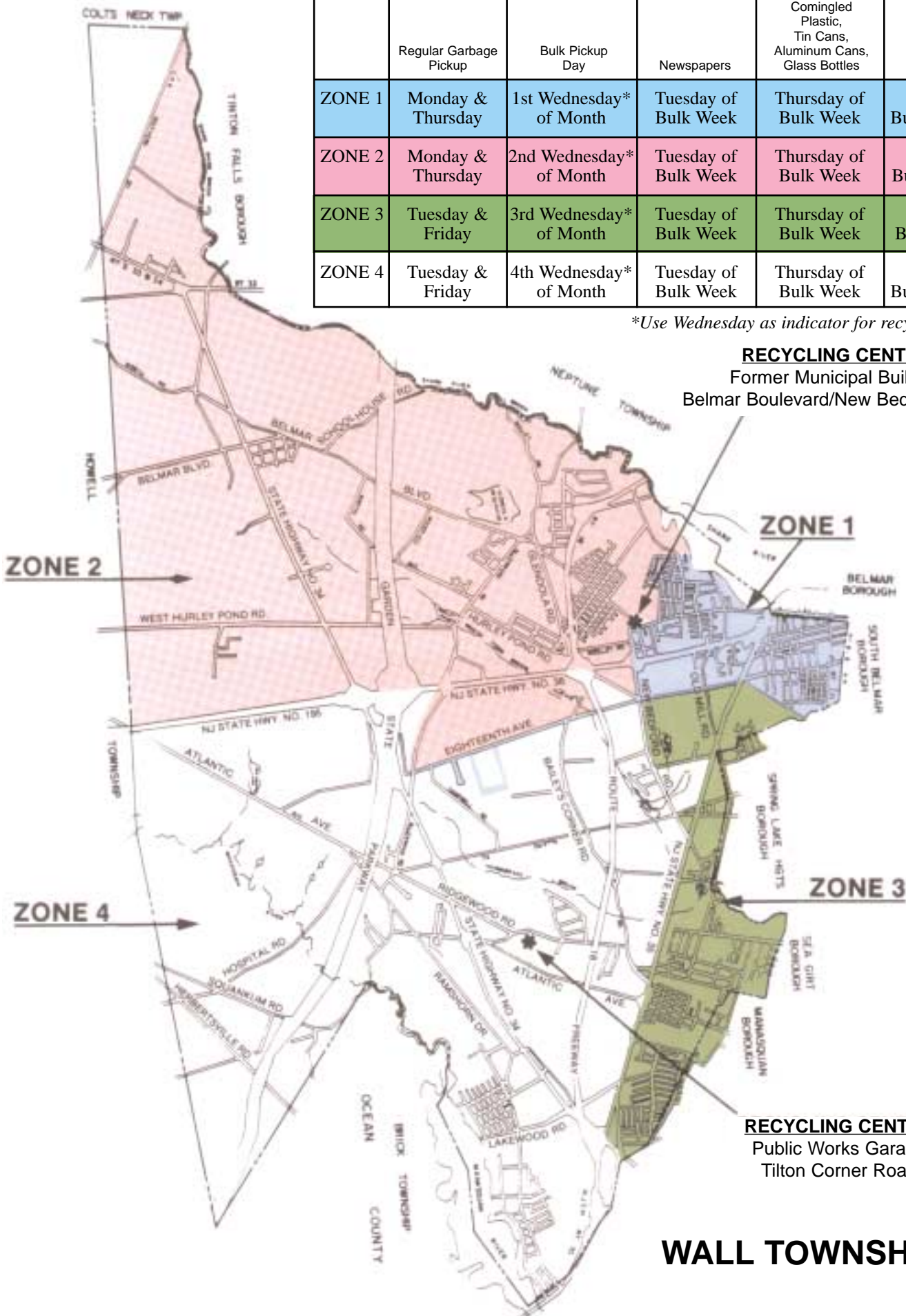

WTEAC Elections

The Wall Township Environmental Advisory Committee re-elected Wilma Morrissey, as Chair; Tony Rembiszewski, as Vice-chair; and Joan Koos, as Secretary. Members of the WTEAC include Mary DeSarno, Ed Loud,

and Cliff Gibson. Mayor Mary Burne serves as liaison to the Township Committee and Dorothy Wilson serves as liaison to the Planning Board. The WTEAC welcomes its newest member, Loren Diedrichsen.

Wreck Pond Nature Park

The Wall Township Environmental Advisory Committee is excited about implementing its goals in 2003. At the February WTEAC meeting, Mr. Joseph Verruni, Township Administrator, unveiled an architectural plan of the newly designed Wreck Pond Nature Park that is located in a watershed area off Route 71. The Township commissioned Melillo & Bauer to capture the visualization of passive recreation while providing a sanctuary and natural habitat for wildlife.

The plan incorporates kiosks that will be placed at strategic points for informational

and educational information, walking trails, park benches, an overlook gazebo, naturalistic plantings and grasses, as well as pavers. There will be space for approximately 22 vehicles.

The WTEAC wholeheartedly endorsed the plan with some modifications. Once the site is completed, improvements and development can be added over the next few years by the initiation of grants.



Educational Native Landscaping Project

The WTEAC has a matching grant to develop a native landscaping demonstration garden along the bike trail in the Allenwood Park. Native plantings require a minimum of care and maintenance. Integrated pest management methods will be utilized for this organic landscaping. The WTEAC will provide brochures, which describe the different varieties used, minimal maintenance practices, and other educational info that will be useful to homeowners and residents.

The brochure will provide alternative landscaping

techniques that can reduce non-point source pollution to our environment. This can be accomplished by avoiding the excess use of fertilizers and pesticide detrimental to the environment in this municipality and the Manasquan Watershed area.

Signage will be placed in this educational demonstration project to identify the native plants. The WTEAC would welcome community volunteers to help with the plantings this spring. Please contact the WTEAC by calling Mrs. Morrissey at (732) 938-3550.



Arbor Day 2003 Tree Planting Project

The WTEAC succeeded in gaining a Partnership Agreement with the New Jersey Tree Foundation to support Wall Township's participation in New Jersey' celebration

of Arbor Day. **WTEAC volunteers from throughout the community planted 163 trees on Wall Township public lands in late April.**

Stormwater Management Controls

What is non-point source pollution?

Non-point pollution is stormwater runoff from impervious coverage that carries pollutants into our stormwater drainage systems through every day litter, chemical lawn products, pet waste, leakage of outflow pipes, construction activities and development. As residents of Wall, we can reduce or limit unnecessary pesticides and fertilizer treatments of lawns, and we can properly dispose of pet waste and yard products.

In addition, filter systems to catch pollutants, retrofitting storm sewer grates, and applying best management practices by municipalities can help protect and preserve our precious, limited water resources and to replenish vital ground water supplies. Public outreach and education would help the community better understand the complexity of the effects of stormwater/non-point-source pollution. This pollution could result in an increase of drinking water treatment costs as well as produce other negative outcomes.

The fish advisories, which were recently announced, highlight the harmful impact of pollution in lakes, streams, and rivers, throughout New Jersey that may require remediation efforts. New NJDEP storm water rules and initiatives will stress the improvement of standards for ground water recharge and water quality controls which should provide us with cleaner, safer water for all to enjoy.

The WTEAC is committed to protecting and preserving our natural resources in Wall. We are well aware that it is our responsibility to serve you, our Wall community, with the utmost care that you deserve. Therefore, we welcome any ideas or suggestions that you would like to share with us. We would like the opportunity of providing you with the educational seminars and workshops of your own choosing. In addition, we are honored to have Mayor Mary Burne, who, as our liaison, would be more than happy to help you with any of your environmental concerns.

Did you know that?

- Aluminum**.....Recycling one aluminum beverage can save enough energy to run a 100-watt bulb for 20 hours, a computer for 3 hours, or a TV for 2 hours.
- Plastic**.....Plastics require 100 to 400 years to break down at the landfill.
- Glass**.....The energy saved from recycling one glass bottle will operate a 100-watt light bulb for four hours.
- Steel**.....One ton of recycled steel saves the energy equivalent of 3.6 barrels of oil and 1.49 tons of iron ore over the production of new steel.
- Paper**.....Preventing 1 ton of paper waste saves between 15 and 17 mature trees.

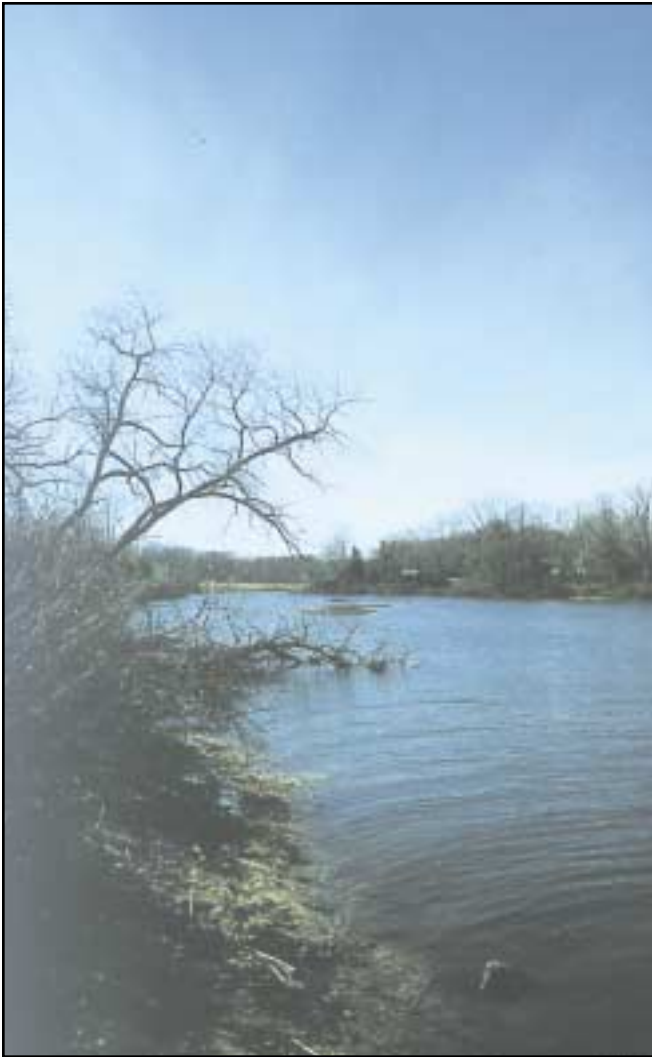
