

**A RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AUTHORIZING THE APPOINTMENT OF VARIOUS PROFESSIONALS FOR THE YEAR 2013.**

**WHEREAS**, there exists the need for the services of various professionals for the Township of Wall for the year 2013; and
