

**A RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL  
AUTHORIZING THE APPOINTMENT OF VARIOUS PROFESSIONALS FOR THE  
YEAR 2012.**
