

TOWNSHIP OF WALL

ORDINANCE NO. 17-1996

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING BOND ORDINANCE NO. 22-1990 AS AMENDED BY BOND ORDINANCE NO. 28-1993 AND BOND ORDINANCE NO. 30-1995 OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, NEW JERSEY, IN ORDER TO AMEND THE DESCRIPTION THEREFOR, FOR THE IMPROVEMENT OF THE WRECK POND SEWERAGE SYSTEM.

BE IT ORDAINED by the Township Committee of the Township of Wall, in the County of Monmouth, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

Section One. Section 3(a) of Bond Ordinance numbered 22-1990 of the Township of Wall, finally adopted June 13, 1990, as amended by Bond Ordinance No. 28-1993 of the Township of Wall, finally adopted December 7, 1993, and as further amended by Bond Ordinance No. 30-1995 of the Township of Wall finally adopted November 29, 1995, is hereby further amended by the addition thereto of the following subparagraph to include additional properties to be improved under such section, which shall read in full as follows:

"Section 3.(a)(i) The improvement heretofore authorized and the purpose for the financing of which the bonds are to be issued is the improvement of the Wreck Pond sewerage system, which improvement shall also extend to the following properties which shall be benefitted thereby and which shall be subject to assessment therefor:

Block 751, Lot 50 and Block 754, Lots 1, 39, 40, 41 and 42."

Section Two. The capital budget of the Township of Wall is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section Three. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

NOTICE OF PENDING BOND ORDINANCE

The Ordinance published herewith was introduced and passed upon first reading at a regular meeting of the governing body of the Township of Wall, in the County of Monmouth, State of New Jersey, held on August 14, 1996. It will be further considered for final passage, after public hearing hereon, at a meeting of the governing body to be held in the Meeting Room, in the Township on August 28, 1996 at 8:00 P.M., and during the week prior to and up to and including the date of such meeting, copies of said bond ordinance will be made available at the Clerk's Office to the members of the general public who shall request the same.
