

TOWNSHIP OF WALL**ORDINANCE NO. 1 - 1996**

**BOND ORDINANCE AMENDING BOND ORDINANCE
NUMBERED 18 - 1994 OF THE TOWNSHIP OF WALL, IN
THE COUNTY OF MONMOUTH, NEW JERSEY FINALLY
ADOPTED SEPTEMBER 14, 1994 IN ORDER TO AMEND
THE DESCRIPTION OF THE PROJECT.**

**BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE
TOWNSHIP OF WALL**, in the County of Monmouth, State of New Jersey (not less than two-thirds of all members thereof affirmatively concurring), as follows:

Section 1. Section 3 (a) of Bond Ordinance numbered 18 - 1994 of the Township of Wall finally adopted September 14, 1994, as amended by Ordinance No. 9 - 1995, finally adopted April 12, 1995, is hereby further amended to read as follows:

“(a) The improvement hereby authorized and the purpose for the financing of which the bonds are to be issued is for the acquisition of lands for open space and active and passive recreation known as Block 771, Lot 32; Block 272, Lot 3; Block 954, Lot 5; Block 275, Lot 3; Block 275, Lot 2; and Block 804, Lots 8 & 11; all as shown on the tax assessment map of the Township; and such other properties as the Township Committee shall determine by amendment to this bond ordinance.”

Section 2. The capital budget of the Township of Wall is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 3. This bond ordinance shall take effect twenty (20) days after the

first publication thereof after final adoption, as provided by the Local Bond Law.

Notice the Ordinance published herewith was introduced and passed upon first reading at a meeting of the governing body of the Township of Wall, in the County of Monmouth, State of New Jersey, held on January 3, 1996.
