

TOWNSHIP OF WALL

ORDINANCE NO. 19-1994

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING CHAPTER VII, "TRAFFIC", OF THE "REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977", AS AMENDED AND SUPPLEMENTED, SECTION 7-11, "SPEED LIMITS".

WHEREAS, the Township has performed the necessary speed surveys and investigations required for establishing speed limits; and

WHEREAS, the Department of Transportation of the State of New Jersey has authorized the Township to set speed limits on New Bedford Road and Bedford Corner Lane;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall, County of Monmouth, State of New Jersey, as follows:

Section 1. Chapter VII, "Traffic" of "The Revised General Ordinances of the Township of Wall, 1977" as amended and supplemented, Schedule XVI "Speed Limits" is hereby amended and supplemented to delete the current entry for New Bedford Road and to add the following two speed limit designations:

(a) "New Bedford Road:

35 miles per hour from Ocean Road to Belmar Boulevard.

Notwithstanding the foregoing, it is established in the area of the Wall Primary School, between the hours of 8:00 o'clock a.m. and 3:30 p.m., a speed limit of 25 miles per hour."

(b) "Bedford Corner Lane

25 miles per hour along the entire length."

Section 2. All Ordinances, or parts thereof, inconsistent with the provisions of this Ordinance, be and the same are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section 4. This Ordinance shall take effect immediately upon its passage and publication according to law.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on August 10, 1994 and will be further considered for final passage and adoption at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on August 24, 1994 at 8:00 o'clock p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall Town Hall to the members of the general public who shall request the same.
