

TOWNSHIP OF WALL

ORDINANCE NO. 25 - 1994

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING SCHEDULE VIII "STOP INTERSECTIONS", OF SECTION 7-6.2, "STOP INTERSECTIONS", AND SECTION 7-11, "SPEED LIMITS", OF CHAPTER VII, "TRAFFIC", OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977", AS AMENDED AND SUPPLEMENTED.

WHEREAS, the Revised General Ordinances of the Township of Wall, 1977, as amended and supplemented, Section 7-6.2 "Stop Intersections", provides that: "pursuant to the provisions of N.J.S.A. 39:4-140 the intersections described in Schedule VIII attached to and made a part of this chapter are hereby designated as stop intersections. Stop signs shall be installed as provided therein"; and

WHEREAS, the Township has performed the necessary speed surveys and investigations required for establishing speed limits; and

WHEREAS, the Department of Transportation of the State of New Jersey has authorized the Township to set speed limits on Ocean Road;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall, County of Monmouth, State of New Jersey, as follows:

Section 1. Chapter VII, "Traffic" of "The Revised General Ordinances of the Township of Wall, 1977" as amended and supplemented, Schedule XVI "Speed Limits" is hereby amended and supplemented to add the following speed limit

designation:

(a) "Ocean Road:

35 miles per hour from Bailey Corner Road to State Highway No. 35."

Section 2. Chapter VII, "Traffic", Section 7-6.2 "Stop Intersections", Schedule VIII, "Stop Intersections" is hereby supplemented to add thereto the following Stop Intersection Designation:

(a) "Laurel Avenue and Azalea Avenue:

STOP signs shall be installed on Laurel Avenue."

Section 3. All Ordinances, or parts thereof, inconsistent with the provisions of this Ordinance, be and the same are hereby repealed to the extent of such inconsistency.

Section 4. Should any section, paragraph, clause or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section 5. This Ordinance shall take effect immediately upon its passage and publication according to law.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on September 28, 1994 and will be further considered for final passage and adoption at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on October 12, 1994 at 8:00 o'clock p.m., or as soon thereafter as the matter can be reached on the agenda,

at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall Town Hall to the members of the general public who shall request the same.
