ORDINANCE NO. 17 - 1993

AN ORDINANCE TO FIX THE COMPENSATION OF OFFICERS AND EMPLOYEES OF THE TOWNSHIP OF WALL.

BE IT ORDAINED BY THE TOWNSHIP OF WALL IN THE COUNTY OF MONMOUTH AND THE STATE OF NEW JERSEY AS FOLLOWS:

Section 1. Unless otherwise noted the yearly compensation, salaries and wages of various officers and employees shall be paid every two weeks, in lieu of all fees as follows:

Section 3. The salary ranges above mentioned shall be effective and payable as of January 1, 1993.

Section 4. A Resolution shall be adopted by the Township Committee setting forth the specific salaries to be paid following the adoption of this Ordinance.

Section 5. All Ordinances or parts of Ordinances in conflict with this Ordinance, or any part thereof, are hereby repealed as to the conflicting portion or portions.

Section 6. This Ordinance shall take effect when passed and published according to law.
