

TOWNSHIP OF WALL  
ORDINANCE NO. 25-1992

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING CHAPTER VII, "TRAFFIC," SECTION 7-4, "LIMITING THE USE OF STREETS TO CERTAIN CLASS OF VEHICLES", OF THE "REVISED GENERAL ORDINANCE OF THE TOWNSHIP OF WALL, 1977", AS AMENDED AND SUPPLEMENTED PERTAINING TO "TRUCKS OVER FOUR TONS EXCLUDED FROM CERTAIN STREETS".

WHEREAS, "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, Section 7-4, "Limiting the use of streets to certain class of vehicles" provides that "Trucks over four tons gross weight are hereby excluded from the streets or parts of streets described in Schedule V except for the pick up and delivery of material on such streets. Schedule V being attached to and made a part of this chapter"; and

WHEREAS, the police department has recommended additions to the streets included in Schedule V;

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey, as follows:

Section 1. Chapter VII, "Traffic", Section 7-4, "Limiting the use of streets to certain class vehicles", of "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, be and the same is hereby further amended and supplemented by the addition thereto of the following:

<u>Name of Street</u>	<u>Location</u>
Marconi Road	Between Belmar Blvd and Brighton Ave.
Adrienne Road	Between Belmar Blvd and Marconi Road
Monmouth Boulevard	Between Belmar Blvd and Marconi Road

Section 2. All Ordinances, or parts thereof, inconsistent with the provisions of this Ordinance, be and the same are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgement shall not affect or impair the remainder of this Ordinance.

Section 4. This Ordinance shall take effect upon its passage and publication according to law.
