

TOWNSHIP OF WALL

ORDINANCE NO. 32 - 1991

AN ORDINANCE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING CHAPTER VII, "TRAFFIC" SECTION 7-11, "SPEED LIMITS" OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977", AS AMENDED AND SUPPLEMENTED, PERTAINING TO SPEED LIMITS ON GULLY ROAD, AND REPEALING ORDINANCE NO. 6-1991

WHEREAS, "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, Section 7-11, "Speed Limits", provides that "The streets or parts of the streets described in Schedule XVI attached to and made a part of this chapter shall have the speed limits designated in such schedule for both directions of traffic";

NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH AND STATE OF NEW JERSEY, as follows:

Section 1. Ordinance No. 6-1991 entitled "An Ordinance of the Township of Wall Amending and Supplementing Chapter VII, "Traffic", Section 7-11, "Speed Limits" of "The Revised General Ordinances of the Township of Wall, 1977", as Amended and Supplemented, Pertaining to Speed Limits on Waterview Way and Gully Road", finally adopted by the Township Committee of

the Township of Wall on February 27, 1991, be and the same is hereby repealed.

Section 2. Chapter VII, "Traffic", Section 7-11, "Speed Limits", Schedule XVI, "Speed Limits" of "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, be and the same is hereby further amended and supplemented by the addition to said Schedule of the following:

A. "Gully Road:

40 miles per hour from Belmar Boulevard to Remsen Mills Road.

45 miles per hour from Remsen Mills Road to the Township of Wall/Neptune Township border."

Section 3. All ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 4. Should any section, paragraph, clause or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section 5. This Ordinance shall take effect upon its passage and publication according to law and upon the approval of the same by the Commissioner of the New Jersey Department

of Transportation.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on Aug. 14, 1991 and will be further considered for final passage and adopted at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on Aug. 28, 1991 at 8 o'clock p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall Town Hall to the members of the general public who shall request the same.
