

TOWNSHIP OF WALL

ORDINANCE NO. 45 - 1990

AN ORDINANCE OF THE TOWNSHIP OF WALL AMENDING BOND ORDINANCE
NUMBERED 21-1990.

BE IT ORDAINED by the Township Committee of the Township of
Wall in the County of Monmouth and State of New Jersey, as
follows:

Section 1. Section 3(a) of Bond Ordinance numbered 21-1990
of the Township of Wall finally adopted May 23, 1990 is hereby
amended to read as follows:

"Section 3. (a) The improvement hereby authorized and
the purpose for the financing of which the bonds are to be issued
is the improvement of the Water Distribution System consisting of
the construction of new water mains, hydrants, fittings, connections
and other appurtenances within Atlantic Avenue from the existing
water main at West Side Drive to Allenwood Road and within
Allenwood Road from Atlantic Avenue to the end of the existing
main approximately 200 feet northeast of Atlantic Avenue and
from Allaire Road from an existing main approximately 400 feet east
of Baileys Corner Road, eastward to the end of another existing
main located approximately 250 feet east of New Bedford Road and
improvements at the Township's various water plants consisting of
piping, valving and controls in order to allow for the necessary
operation and maintenance of the plants once water is received
into the Township's Water Distribution System from the Manasquan
River Reservoir System, including the acquisition of any

necessary easements and all work and materials necessary therefor or incidental thereto, all as shown on and in accordance with a list on file in the office of Bay Pointe Engineering Associates, Inc."

Section 2. The capital budget of the Township of Wall is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 3. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on Oct. 10, 1990 and will be further considered for final passage and adoption at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on Oct. 24, 1990 at 8 o'clock p.m., or as soon thereafter as the matter can be reached on the agenda at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall Town Hall to the members of the general public who shall request the same.
