

TOWNSHIP OF WALL

ORDINANCE NO. 25 -1990

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING CHAPTER XII, "WATER AND SEWER" OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977", PERTAINING TO BILLING FOR WATER AND SEWER CHARGES.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, COUNTY OF MONMOUTH, STATE OF NEW JERSEY, as follows:

Section 1. Subsection 12-2.10 "Billing for Charges", pertaining to billing for water services, and subsection 12-3.8 "Interest on Overdue Sewer Payment", pertaining to billing for sewer charges, of Chapter XII, "Water and Sewer" of "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, be and the same are hereby further amended and supplemented by the addition to each of the aforesaid subsections of the following subparagraphs:

"b. Billing in 1990. During the year 1990, bills shall be rendered as of July 1, 1990 for one-half the applicable minimum water and sewer service charges and for one-half of all applicable water and sewer excess charges, and such bills shall be paid before August 31, 1990. Bills shall be rendered as of October 1, 1990 for one-half the applicable minimum and excess water and sewer charges, and such bills shall be paid before December 1, 1990. All bills paid after the due date will bear interest at the foregoing rate, which interest shall run from the billing date.

c. Billing in 1991 and Thereafter. After the year 1990, bills for minimum and excess water and sewer charges shall be rendered quarterly as of January 1, April 1, July 1 and October 1 in each year, and shall be paid before March 1, June 1, September 1, and December 1, respectively in each year. All such bills paid thereafter will bear interest at the foregoing rate, which interest shall run from

the billing date. Bills rendered as of January 1 and April 1 shall each consist of one-half the applicable minimum water and sewer service charges. Bills rendered as of July 1 and October 1 shall each consist of one-half of all applicable water and sewer excess charges."

Section 2. All Ordinances, or parts thereof, inconsistent with the provisions of this Ordinance, be and the same are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section 4. This Ordinance shall take effect immediately upon its passage and publication according to law.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on May 9, 1990, and will be further considered for final passage and adoption at the Court Room, Municipal Complex, 2700 Allaire Road, Wall, New Jersey on May 23, 1990 at 8:00 p.m., or as soon thereafter as the matter can be reached on the agenda at which time and place all persons interested therein shall be given an opportunity to be heard and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall Municipal Complex to the members of the general Public who shall request the same.
