

TOWNSHIP OF WALL

ORDINANCE NO. 29-1989

AN ORDINANCE TO AMEND CHAPTER II, "ADMINISTRATION" OF "THE REVISED GENERAL ORDINANCES FOR THE TOWNSHIP OF WALL, 1977," AS AMENDED AND SUPPLEMENTED, TO PROVIDE FOR HOSPITALIZATION INSURANCE FOR EMPLOYEES RETIRING AS A RESULT OF A PERMANENT DISABILITY .

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY as follows:

Section 1. Chapter II, "Administration" Subsection 2-4.12, "Insurance" of the Revised General Ordinances of the Township of Wall, 1977, as amended and supplemented be and the same is hereby amended by the complete deletion of former Subsection 2-4.12(c)2 and by substituting therefor the following:

"2-4.12(c)2. Hospitalization Insurance. Except as hereinafter provided in paragraph 3, this benefit shall terminate upon the employee's separation from service. At that time, the employee may make his own arrangements with the insurance company for the continuation or conversion of the insurance at his own expense. An individual that receives retirement disability from the Public Employment Retirement System and who has at least 15 years of service with the Township shall be entitled to continue to be enrolled in the Family Hospitalization Insurance Plan provided to Township employees pursuant to paragraph 1 hereof, at the Township's expense."

Section 2. All ordinances and parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 3. If any section, subsection, paragraph, sentence, clause or phrase of this ordinance shall be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this ordinance.

Section 4. This ordinance shall take effect immediately upon its final passage and publication according to law.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on May 24, 1989 and will be further considered for final passage and adoption at a meeting of the Township Committee of the Township of Wall at the Municipal Courtroom, Police Headquarters Building, Allaire Road, Township of Wall, on June 14, 1989 at 8 P.M. or as soon thereafter as the matter can be reached on the Agenda, at which time and place all persons interested therein shall be given an opportunity to be heard and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall, Township Hall, to the members of the general public who shall request the same.
