

TOWNSHIP OF WALL

ORDINANCE NO. 34 - 1989

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING CHAPTER XII, "WATER AND SEWER" OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977."

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, COUNTY OF MONMOUTH, STATE OF NEW JERSEY, as follows:

Section 1. Subsection 12-2.10 "Billing for Charges" of Chapter XII, "Water and Sewer", pertaining to billing for water services, and subsection 12-3.8 "Interest on Overdue Sewer Payment", pertaining to bills for sewer charges of Chapter XII, "Water and Sewer" of the "Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, be and the same are hereby further amended and supplemented by the addition to each of the aforesaid subsections of the following subparagraph:

"a. Temporary extension. For bills rendered as of July 1, 1989, for either water service or sewer charges there shall be no interest charged if such bills are paid on or before December 31, 1989. All such bills paid thereafter will bear interest at the foregoing rate, which interest shall run from July 1, 1989."

Section 2. All Ordinances, or parts thereof, inconsistent with the provisions of this Ordinance, be and the same are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or

impair the remainder of this Ordinance.

Section 4. This Ordinance shall take effect immediately upon its passage and publication according to law.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on July 26, 1989 and will be further considered for final passage and adoption at the Court Room, Police Headquarters Building, Allaire Road, Wall, New Jersey, on Aug. 9, 1989 at 8:00 p.m., or as soon thereafter as the matter can be reached on the agenda at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall Town Hall to the members of the general public who shall request the same.
