

TOWNSHIP OF WALL
ORDINANCE NO. 40 - 1989

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VII, "TRAFFIC," OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977," AS AMENDED AND SUPPLEMENTED, PERTAINING TO NO PASSING ZONE FOR GULLY ROAD.

WHEREAS, the Township Committee hereby finds and declares that permitting vehicles to pass on certain streets and roadways within the Township creates a hazardous condition; and

WHEREAS, the Township Police Department has requested, and the New Jersey Department of Transportation in a letter dated August 28, 1989 has approved, a No Passing Zone along the entire length of Gully Road; and

WHEREAS, the Township Committee finds that the establishment of such a No Passing Zone would be beneficial to the health and safety of the citizens of the Township;

NOW, THEREFORE, BE IT ORDAINED by the the Township Committee of the Township of Wall in the County of Monmouth and State of New Jersey as follows:

Section 1. Chapter VII, "Traffic," of the Revised General Ordinances of the Township of Wall, 1977, as amended and supplemented, be and the same is hereby further amended by the addition thereto of the following Section:

"7-16 NO PASSING ZONES.

The streets or parts of streets described in Schedule XVIII attached to and made a part of this chapter shall be designated as No Passing Zones, and no driver of any vehicle shall cross any yellow line on his side of the road for the purpose of passing another vehicle in any such zone."

Section 2. Chapter VII, "Traffic," of the Revised General Ordinances of the Township of Wall, 1977, as amended and supplemented, be and the same is hereby further amended by the addition thereto of the following schedule:

SCHEDULE XVIII
NO PASSING ZONES

In accordance with the provisions of Section 7-16, the following locations shall be No Passing Zones:

<u>Name of Street</u>	<u>Direction</u>	<u>Location</u>
Gully Road	Both directions	From Neptune Township - Wall Township line to Belmar Boulevard

Section 3. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 4. This Ordinance shall take effect upon its passage and publication according to law and upon the approval

of the same by the Commissioner of the New Jersey Department of Transportation.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on *Oct. 11*, 1989 and will be further considered for final passage and adoption at a meeting of the Township Committee of the Township of Wall at the Municipal Courtroom, Police Headquarters Building, Allaire Road, Township of Wall, on *Oct 25*, 1989 at 8 P.M. or as soon thereafter as the matter can be reached on the Agenda, at which time and place all persons interested therein shall be given an opportunity to be heard and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's Office in the Township of Wall, Township Hall, to the members of the general public who shall request the same.
