

TOWNSHIP OF WALL

ORDINANCE NO. 44 - 1989

AN ORDINANCE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING CHAPTER VI "ALCOHOLIC BEVERAGE CONTROL" OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977", AS AMENDED AND SUPPLEMENTED PERTAINING TO THE HOURS OF SALE ON CERTAIN HOLIDAYS AND FEES FOR ALCOHOLIC BEVERAGE LICENSES.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AS FOLLOWS:

SECTION 1. Chapter VI, "Alcoholic Beverage Control", of "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, Section 6-4, "Regulations of Licenses", subsection 6-4.5, "New Year's Day", be and the same is hereby deleted in its entirety and the following substituted therefor:

"6-4.5 Certain Holidays.

a. The provision of subsections 6-4.1 and 6-4.2 shall not apply on January 1. On that day, alcoholic beverages may not be sold, served, delivered or consumed in any licensed premises between the hours of 5:00 a.m. and 7:00 a.m., unless January 1 is a Sunday, in which case alcoholic beverages may not be sold, served, delivered or consumed in any licensed premises between the hours of 5:00 a.m. and 12:00 noon.

b. The provisions of subsection 6-4.1 and 6-4.2 shall not apply on December 24 and December 31 if those dates are Sundays. In such cases, alcoholic beverages shall not be sold, served, delivered or consumed in any licensed premises between the hours of 2:00 a.m. and 9:00 a.m."

SECTION 2. Chapter VI, "Alcoholic Beverage Control", of "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, Section 6-3, "Licenses", subsection 6-3.4, "License Fees; Maximum Number", be and the same is hereby deleted in its entirety and the following substituted therefor:

"6-3.4 License Fees; Maximum Number. The annual fee and maximum number of licenses for the sale or distribution of alcoholic beverages in the township shall be as follows:

Plenary Retail Consumption License	\$1,775.00	13
Plenary Retail Distribution License	\$1,050.00	2"

SECTION 3. All Ordinances, or parts thereof, inconsistent with the provisions of this Ordinance, be and the same are hereby repealed to the extent of such inconsistency.

SECTION 4. Should any section, paragraph, clause, or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

SECTION 5. This Ordinance shall take effect immediately upon its passage and publication according to law.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on *November 14, 1989* and will be further considered for final passage and adoption at the Court Room, Police Headquarters Building, Allaire Road, Wall, New Jersey, on *November 29, 1989* at 8:00 p.m., or as soon thereafter as the matter can be reached on the agenda at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall Town Hall to the members of the general public who shall request the same.
