

TOWNSHIP OF WALL

ORDINANCE NO. 3 - 1988

AN ORDINANCE TO FIX THE COMPENSATION OF OFFICERS IN THE POLICE DEPARTMENT OF THE TOWNSHIP OF WALL.

BE IT ORDAINED BY THE TOWNSHIP OF WALL IN THE COUNTY OF MONMOUTH AND THE STATE OF NEW JERSEY AS FOLLOWS:

Section 1. Unless otherwise noted the yearly compensation salaries and wages of various officers and employees shall be paid every two weeks, in lieu of all fees, as follows:
