

TOWNSHIP OF WALL

ORDINANCE NO. 17-1988

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VII, "TRAFFIC", SECTION 7-11 "SPEED LIMITS", SECTION 7-3.5 "STOPPING OR STANDING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS", AND SECTION 7-9 "BUS STOPS" OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977", AS AMENDED AND SUPPLEMENTED, PERTAINING TO THE SPEED LIMIT ON RAMSHORN DRIVE, STOPPING AND STANDING REGULATIONS ON VARIOUS ROADWAYS, AND THE ESTABLISHMENT OF A BUS STOP ON 17th AVENUE.

BE IT ORDAINED by the Township Committee of the Township of Wall in the County of Monmouth and State of New Jersey as follows:

Section 1. Chapter VII, "Traffic", Section 7-11, "Speed Limits", Schedule XVI, "Speed Limits", be and the same is hereby amended and supplemented by deleting therefrom all references to Ramshorn Drive, and by substituting the following therefor:

"Ramshorn Drive: 35 miles per hour along the entire length".

Section 2. Chapter VII, "Traffic", Section 7-3.5, "Stopping or Standing Prohibited During Certain Hours on Certain Streets", provides that no person shall stop or stand a vehicle between the hours specified in Schedule III. Schedule III, "No Stopping or Standing", of Chapter VII, "Traffic", be and the same is hereby amended and supplemented by the addition thereto of the following streets and portions of streets on which no person shall stop or stand a vehicle between the hours specified, except Sundays and public holidays:

Section 3. Chapter VII, "Traffic", Section 7-9, "Bus Stops", Schedule XII, "Bus Stops", be and the same is hereby further amended by the addition thereto of the following street and location on which a bus stop is hereby established during the hours indicated:

<u>"Name of Street</u>	<u>Location</u>	<u>Hours</u>
17th Avenue	At a point 100' east of I Street for a distance of 65' along the south side of 17th Street	8 a.m. to 4 p.m."

Section 4. Regulatory and warning signs shall be erected and maintained to effect the above designated speed limit, no stopping and standing zones, and bus stop, as authorized by the New Jersey Department of Transportation.

Section 5. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 6. Should any section, clause, sentence or other

portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

Section 7. This Ordinance shall take effect immediately upon its passage and publication, subject to the approval of the Commissioner of the Department of Transportation, and the approval of the Monmouth County Board of Chosen Freeholders as to all County roadways which are referred to herein.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on April 13, 1988, 1988, and will be further considered for final passage and adoption at the Court Room, Police Headquarters Building, Allaire Road, Wall, New Jersey, on April 27, 1988, 1988, at 8:00 P.M., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's Office in the Township of Wall Town Hall to the members of the general public who shall request the same.
