A RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AUTHORIZING THE APPOINTMENT OF TOWNSHIP CONSULTING PROFESSIONALS FOR THE YEAR 2015.
