RESOLUTION NO. 22-1009

AUTHORIZATION FOR THE PUBLIC AUCTION SALE OF VARIOUS SURPLUS ITEMS DEEMED UNNECESSARY FOR MUNICIPAL OPERATION, OPENING ON NOVEMBER 5, 2022 CLOSING NOVEMBER 10, 2022

WHEREAS, the Township of Wall Police Department and Department of Public of Works are in the possession of motor vehicles and other property, which have been seized or which have been previously owned or abandoned and not claimed (the "Vehicles"), and;

WHEREAS, the motor vehicles and other property are no longer needed for public use; and

WHEREAS, the police vehicles and other property have met the end of their useful service life; and

WHEREAS, the vehicles and other property are more particularly described on the attached Notice of Sale incorporated herein by reference; and

WHEREAS, the Township Committee of the Township of Wall has decided that the aforesaid vehicles and other property shall be sold at a public auction to be conducted by the Wall Township Police Department; auction opens: November 5, 2022; auction closes: November 10, 2022, beginning at 7:00 PM EST with 1-minute intervals; and

WHEREAS, Location for Inspection: Wednesday, November 9, 2022 from 9:00 AM to 12:00 PM at Wall Township Police Department, 2700 Allaire Rd, Wall, NJ 07719. An attempt to start vehicles engines will commence between 9:00 A.M. and 11:00 A.M.; and


WHEREAS, the Division of Local Government Services has approved Internet-based vendors for online auctions of surplus personal property; one of those vendors being used for online auction is usgovbid.com; and

WHEREAS, the Division of Local Government Services authorized municipalities to use online auctions without DCA approval and without going out to bid; and

WHEREAS, the Township of Wall has previously adopted Resolution No. 14-1113, which authorized the Public Auction Sale of various items.

BE IT FURTHER RESOLVED, that the Township Clerk be and is hereby authorized to cause public notice of the aforesaid auction sale, to be published pursuant to N.J.S.A. 40A:11-36, in The Coast Star.
