**AUTHORIZATION TO AWARD A CONTRACT TO AMUSEMENTS OF AMERICA FOR THE FURNISHING AND DELIVERY OF AMUSEMENTS, FOOD VENDORS AND GAMES FOR THE YEAR 2023 WALL TOWNSHIP FAIR**

**WHEREAS**, the Township of Wall advertised and solicited bids for the furnishing and delivery of amusements, food vendors and games for the 2023 Wall Township Fair to be held June 29, 2023 through July 2, 2023 at Wall Township Municipal Complex; and,



**WHEREAS**, the Township of Wall received a single bid from Amusements of America, located at PO Box 369, Tennent, NJ 07763 to provide these services to the Township; and,

**WHEREAS**, Amusements of America has proposed paying the Township of Wall 30% of ticket proceeds up to \$175,000.00 ride gross amusement ticket sales after taxes and 10% commission for the mega-band passes and \$25.00 (twenty-five dollars) for each amusement game and \$350.00 (three hundred fifty) for each food vendor and proposes providing six (6) food vendors and minimum of six (6) amusement games for the Wall Township Fair; and,

**WHEREAS**, the Wall Township Director of Recreation, has evaluated the proposal for qualifications, experience and cost reasonableness, and recommends the award of the contract to Amusements of America.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Wall, County of Monmouth, New Jersey that the Township award the contract for the furnishing and delivery of amusements, food vendors and games for the 2023 Wall Township Fair.

**BE IT FURTHER RESOLVED**, that all Township officials including, but not limited to the Mayor, the Township Administrator and the Municipal Clerk, are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the provisions of this resolution.
