AUTHORIZATION TO ADOPT TEMPORARY APPROPRIATIONS FOR 2017

WHEREAS, N.J.S.A. 40A: 4-19 provides that where any contract, commitment or payment are to be made prior to the final adoption of the 2017 budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

WHEREAS, the date of this resolution is within the first thirty days of January, 2017; and

WHEREAS, the total appropriations in the 2016 budget, exclusive of any appropriations for interest, debt service, capital improvement fund, and public assistance, was the sum of \$41,587,466.65; and


WHEREAS, one-fourth of the total appropriations in the 2016 budget, exclusive of any appropriations made for interest, debt service, capital improvement fund and public assistance, is the sum of \$10,396,866.67; and
