RESOLUTION NO. 18-0130

**AUTHORIZING 2018 TEMPORARY APPROPRIATIONS AND DEBT SERVICE AS
PER 40A:4-19**

WHEREAS, N.J.S.A. 40A: 4-19 provides that where any contract, commitment or payment are to be made prior to the final adoption of the 2018 Municipal Budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

WHEREAS, the date of this resolution is within the first thirty (30) days of the fiscal year; and

WHEREAS, the total appropriations in the 2017 Municipal Current Fund Budget and Water/Sewer Utility Budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund and public assistance, is the sum of \$36,618,918.93 and \$11,246,555.29 respectively; and


WHEREAS, 26.25% of the total appropriations in the 2017 Municipal Current Fund Budget and Water/Sewer Utility Budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund and public assistance in said budget is the sum of \$9,612,466.22 and \$2,952,220.76 respectively; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall, in the County of Monmouth, New Jersey, that the following appropriations be made effective to January 1, 2018 and that a certified copy of this resolution be transmitted to the Chief Financial Officer for his records:
