**ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF  
WALL AMENDING CHAPTER 222 OF THE CODE OF THE TOWNSHIP OF  
WALL ENTITLED WATER AND SEWERS**

**WHEREAS**, the Township of Wall presently bills water and sewer customers for services on a quarterly basis under Chapter 222 of the Code of the Township of Wall entitled Water and Sewers; and

**WHEREAS**, the Township of Wall is seeking to make the per unit charge for sewer consistent with the per unit charge for water;

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Wall as follows:

**SECTION ONE**

Chapter 222 of the Code of the Township of Wall is hereby amended as follows:

§222-40A is hereby amended to indicate “except for owner-occupied premises with not more than two single-family dwelling units”.

**SECTION TWO**

Accordingly, Chapter 222-40A of the Code of the Township of Wall shall read as follows: When multiple uses or enterprises exist within a single system user or on a single property, separate unit user charges shall be applied to each applicable type or use contained therein as set forth in this schedule; except for owner-occupied premises with not more than two single-family dwelling units.

**SECTION THREE**

If any part of this Ordinance shall be deemed invalid by an administrative agency or court of competent jurisdiction, such decision shall not affect the legality and enforceability of any other provision hereof.

**SECTION FOUR**

All ordinances, policies and or procedures or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency.

**SECTION FIVE**

This Ordinance shall take effect upon final passage and publication as provided by law.
