**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING CHAPTER 215 OF THE CODE OF THE TOWNSHIP OF WALL ENTITLED VEHICLES AND TRAFFIC PERTAINING TO CHAPTER 215-48 SCHEDULE XVI: SPEED LIMITS**

**WHEREAS**, the Township of Wall is desirous of amending Chapter 215 of the Code of the Township of Wall entitled Vehicles and Traffic pertaining to speed limits; and,

**WHEREAS**, the Director of Engineering and Planning in conjunction with the Police Department has recommended to the Township Committee that the speed limit on West Chicago Boulevard be reduced from 35 mph to 30 mph; and

**WHEREAS**, the Township Committee finds that this change would be beneficial to the Township and its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Wall as follows:

**SECTION ONE**

Section 215-48 is hereby amended by the addition of the following:

**§215-48** – Schedule XVI: Speed Limits

Name of Street	Speed Limit (mph)	Limits
West Chicago Boulevard	30	Entire length

**SECTION TWO**

If any part of this Ordinance shall be deemed invalid by an administrative agency or court of competent jurisdiction, such decision shall not affect the legality and enforceability of any other provision hereof.

**SECTION THREE**

All ordinances, policies and or procedures or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency.

**SECTION FOUR**

This Ordinance shall take effect upon final passage and publication as provided by law.
