AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP
OF WALL AMENDING AND SUPPLEMENTING CHAPTER 9 OF THE
CODE OF THE TOWNSHIP OF WALL PERTAINING TO SIGNING AND
ISSUANCE OF CHECKS

BE IT ORDAINED by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey, as follows:

Section 1. Chapter 9, "Payment of Claims", of the Code of the Township of Wall, Section 9-7, "Signing and issuance of checks", be and the same is hereby amended and supplemented by the deletion thereto in its entirety and the addition thereto of the following:

§9-7. Signing and issuance of checks

Checks shall be signed on behalf of the Township by any three of the following Township officials: The Mayor, the Deputy Mayor, the Township Administrator, or in his/her absence the Assistant Township Administrator, The Township Clerk, or in his/her absence the Deputy Township Clerk, the Chief Financial Officer, or in his/her absence the Assistant Chief Financial Officer.

Section 2. All ordinances, or parts thereof, inconsistent with the provisions of this ordinance be and the same are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section 4. This Ordinance shall take effect immediately upon its passage and publication pursuant to law.
