AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP  
OF WALL AMENDING AND SUPPLEMENTING CHAPTER 215-45 OF  
THE CODE OF THE TOWNSHIP OF WALL PERTAINING TO SCHEDULE  
XIII: NO LEFT TURN

BE IT ORDAINED by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey, as follows:

**Section 1.** Chapter 215, "Vehicles and Traffic", of the Code of the Township of Wall, Section 45, "Schedule XIII No Left Turn", be and the same is hereby amended and supplemented by the addition thereto of the following:

**§215-45 Schedule XIII - No Left Turn**

<b><u>Location</u></b>	<b><u>Direction</u></b>	<b><u>Prohibited</u></b>
Intersection Route NJ 35 and 17 <sup>th</sup> Avenue	From Westbound 17 <sup>th</sup> Avenue to Southbound onto Route NJ 35	No Left Turn

**Section 2.** All ordinances, or parts thereof, inconsistent with the provisions of this ordinance be and the same are hereby repealed to the extent of such inconsistency.

**Section 3.** Should any section, paragraph, clause or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

**Section 4.** A copy of this Ordinance shall be sent to the New Jersey Department of Transportation

**Section 4.** This Ordinance shall take effect immediately upon its passage and publication pursuant to law.
