**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF
WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY,
AMENDING CHAPTER 222 OF THE CODE OF THE TOWNSHIP OF WALL
ENTITLED WATER AND SEWER**

BE IT ORDAINED by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey, as follows:

WHEREAS, Administrator Bertrand has recommended amendments to Sections 3 and 4 of Chapter 222 “Water and Sewer” of the Township of Wall; and

WHEREAS, the Township Committee concurs with the recommendations of Administrator Bertrand and is desirous of amending Sections 3 & 4 of Chapter 222 of the Township of Wall; and

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall as follows:

SECTION ONE

Chapter 222, §3 of the Code of the Township of Wall is updated as follows:

§ 222-3 Application for service connection.

B. The fee for tapping of the water main, installing corporation cock, service pipe to the curbs, curb stop and curb box shall be as follows:

Size of Tap (inches)	Installation Fee
¾	\$2,204.04 CHANGE TO <u>\$2,024.04</u>
1	\$2,333.76 (No change)
1 ½	\$3,111.89 CHANGE TO <u>\$2,717.34</u>
