**AUTHORIZATION TO EXECUTE A CONTRACT FOR THE PURCHASE OF
VARIOUS SCBA EQUIPMENT AT A PRICE NOT TO EXCEED \$3,813.30 THROUGH
STATE CONTRACT FROM NEW JERSEY FIRE EQUIPMENT COMPANY**

WHEREAS, the Board of Fire Commissioners, Fire District No. 2 wishes to purchase various SCBA equipment; and

WHEREAS, the various SCBA equipment being recommended for purchase from New Jersey Fire Equipment Company under State Contract are as follows:

- RIT Pak III in the amount of \$3,168.00 (three thousand one hundred sixty-eight dollars)
- Facepiece Kevlar Head Harness: 5 strap in the amount of \$156.60 (one hundred fifty-six dollars and sixty cents)
- Facepiece Kevlar Head Harness: 4 strap in the amount of \$156.60 (one hundred fifty-six dollars and sixty cents)
- 2015 AV300HT Facepiece in the amount of \$332.10 (three hundred thirty-two dollars and ten cents)


