RESOLUTION NO. 20-0306

AUTHORIZATION TO EXECUTE A CONTRACT WITH WINNER FORD FOR THE PURCHASE OF SIX (6) POLICE INTERCEPTOR VEHICLES THROUGH STATE CONTRACT NO. 88728 AT A PRICE NOT TO EXCEED \$192,954.00

WHEREAS, the Township Committee is desirous of purchasing six (6) Police Interceptors from Winner Ford through State Contract No. 88728; and

WHEREAS, the six (6) Police Interceptors vehicles being purchased are through State Contract No. 88728 from Winner Ford at a price not to exceed \$192,954.00 (one hundred ninety-two thousand nine hundred fifty-four dollars and zero cents) for all six (6) vehicles; and


WHEREAS, Kenneth Brown, Chief of Police, recommends that the Township Committee purchase the six (6) Police Interceptor vehicles through State Contract; and

WHEREAS, the Township Administrator concurs with the recommendation to purchase the six (6) Police Interceptors through the State Contract No. 88728 at a price not to exceed \$192,954.00 (one hundred ninety-two thousand nine hundred fifty-four dollars and zero cents) for all six (6) vehicles; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Kenneth Brown, Chief of Police, to authorize the purchase of the following: (6) Police Interceptors through State Contract No. 88728 at a price not to exceed \$192,954.00 (one hundred ninety-two thousand nine hundred fifty-four dollars and zero cents) for all six (6) vehicles
2. This resolution is subject to the filing of a certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other appropriate Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
