WHEREAS, Wall Township Assistant Administrator, Kathleen Kohri, evaluated the proposals for qualifications, experience and cost reasonableness, and recommends the award of a contract to PDEC/Safeguard of Eatontown, NJ, in an amount not to exceed \$5,425.00 (five thousand four hundred twenty-five dollars); and


WHEREAS, the Chief Financial Officer of the Township certified that the Township has the available funds to cover the costs associated with the contract


