

**TOWNSHIP OF WALL**

**RESOLUTION NO. 19-0314**

**AUTHORIZATION TO RENEW A MINING LICENSE FOR BLOCK 930 LOT 1, 1401  
SCHOOLHOUSE ROAD AND BLOCK 922 LOT 5, 1875 HIGHWAY 34**

**WHEREAS**, pursuant to Section 150-3 of the Township code of the Township of Wall, no mining or excavating shall be conducted within the Township unless one of the following conditions is satisfied; a license has been obtained; the mining activity is permitted by the Zoning Ordinance; the mining activity has been granted by variance; or the mining activity has been established to be a valid non-conforming use; and

**WHEREAS**, Fred McDowell, Inc., has applied for a mining license for the 2019-2020 license term pertaining to properties known and designated on the tax assessment map of the Township as Block 930 Lot 1 and Block 922 Lot 5; and

**WHEREAS**, the property owner has submitted applications which substantially conform to the requirements set forth in the Township's Ordinance pertaining to mining licenses as to Block 930 Lot 1 and Block 922 Lot 5, which applications have been reviewed by the Matt Zahorsky, P.E. Director of Engineering and Planning; and

**WHEREAS**, it has been determined by Matt Zahorsky, P.E. Director of Engineering and Planning that prior mining activities have been in compliance with the plans previously approved by the Township; and

**WHEREAS**, the property owner has provided certificates to continue the effectiveness of the required bonds pertaining to each of the properties in questions; and


**WHEREAS**, the Township Committee has reviewed the report of Matt Zahorsky, P.E. Director of Engineering and Planning pertaining to the aforesaid properties; and

**WHEREAS**, the Township Committee finds that it would be in the best interest of the Township to grant the license requested only upon certain special conditions necessary to protect the public health, safety, and welfare and to insure compliance with applicable Township Ordinances.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Wall that the mining license applications of Fred McDowell, Inc., for the properties known and designated as Block 930 Lot 1 and Block 922 Lot 5 be and the same are hereby granted for the 2019-2020 license term, subject to the following conditions:

1. As to each of the aforesaid licenses, receipt by the Township Clerk of a certification from the Tax Collector that all taxes and assessments presently due and owing on the subject properties have been paid.
2. Compliance with the application submitted and the terms of all applicable ordinances of the Township.
