RESOLUTION NO. 19-0628

**AUTHORIZATION TO EXECUTE A CONTRACT WITH MARATHON EQUIPMENT CO. FOR THE PURCHASE OF ONE (1) 34 YARD COMPACTOR THROUGH SOURCEWELL COOPERATIVE PURCHASING AT A PRICE NOT TO EXCEED \$23,877.45**

**WHEREAS**, the Township of Wall Committee is desirous of purchasing a 34-yard compactor for cardboard from Marathon Equipment Co. through Sourcewell (formerly National Joint Powers Alliance); and,

**WHEREAS**, the Model 18XP Brush Bandit is the chipper being recommended for purchase and the Model RJ250 sc 34yd is the compactor recommended for purchase through Sourcewell at a price not to exceed \$23,877.45 (twenty-three thousand eight hundred seventy-seven dollars and forty-five cents).; and

**WHEREAS**, Joseph Lentini, Director of Public Works, recommends that the Township Committee purchase the 34-yard compactor for cardboard from Marathon Equipment Co. through Sourcewell; and


**WHEREAS**, the Township Administrator concurs with the recommendation to purchase of the 34-yard compactor for cardboard through Sourcewell at a price not to exceed \$23,877.45 (twenty-three thousand eight hundred seventy-seven dollars and forty-five cents); and

**WHEREAS**, the Township of Wall entered into the National Purchasing Program on July 28, 2016.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Joseph Lentini, Director of Public Works to authorize the purchase of a 34-yard compactor for cardboard from Marathon Equipment Co. through Sourcewell at a price not to exceed \$23,877.45 (twenty-three thousand eight hundred seventy-seven dollars and forty-five cents).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
