**AUTHORIZATION TO EXECUTE A CONTRACT WITH GILLESPIE GROUP, INC.
FOR THE PURCHASE CARPET FOR THE MUNICIPAL COURT AND
RECREATION DEPARTMENTS WITHIN THE MUNICIPAL BUILDING
THROUGH THE EDUCATIONAL SERVICES COMMISSION OF NEW JERSEY
(EXCNJ) AT A PRICE NOT TO EXCEED \$11,440.76**

WHEREAS, the Township Committee is desirous of purchasing carpet for the Municipal Court and Recreation Departments within the Municipal Building from Gillespie Group, Inc. through the Educational Services Commission of New Jersey; and

WHEREAS, the carpeting being recommended for purchase is under the Educational Services Commission of New Jersey from Gillespie Group, Inc. at a price not to exceed \$11,440.76 (eleven thousand four hundred forty dollars and seventy-six cents); and

WHEREAS, Joseph Lentini, Director of Public Works, recommends that the Township Committee purchase the carpeting under cooperative purchasing; and


WHEREAS, the Township Administrator concurs with the recommendation to purchase the carpeting through the Educational Services Commission of New Jersey at a price not to exceed \$11,440.76 (eleven thousand four hundred forty dollars and seventy-six cents); and

WHEREAS, the Township of Wall entered into the Educational Services Commission of New Jersey on March 12, 2014.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby concurs with the recommendations of Joseph Lentini, Director of Public Works, to authorize the purchase of the following: carpeting for the Municipal Court and Recreation Department within the Municipal Building under the Educational Services Commission of New Jersey from Gillespie Group, Inc. at a price not to exceed \$11,440.76 (eleven thousand four hundred forty dollars and seventy-six cents).
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C.5:30-5.3 (a).
3. The Mayor, Municipal Clerk and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.
