

**TOWNSHIP OF WALL
RESOLUTION NO. 18-0319**

**AUTHORIZING THE PUBLIC AUCTION SALE OF VARIOUS SURPLUS ITEMS
DEEMED UNNECESSARY FOR MUNICIPAL OPERATION, OPENING ON APRIL 14,
2018 CLOSING APRIL 18, 2018**

WHEREAS, the Township of Wall Police Department is in the possession of motor vehicles, which have been seized or which have been previously owned or abandoned and not claimed (the "Vehicles"), and;

WHEREAS, the motor vehicles are no longer needed for public use; and

WHEREAS, the police vehicles have met the end of their useful service life; and

WHEREAS, the vehicles are more particularly described on the attached Notice of Sale incorporated herein by reference; and

WHEREAS, by the Township Committee of the Township of Wall that the aforesaid vehicles shall be sold at a public auction to be conducted by the Wall Township Police Department; auction opens: April 14, 2018; auction closes: April 18, 2018 beginning at 7:00 PM EST with 1-minute intervals; and

WHEREAS Location for Inspection: Friday, April 13, 2018 from 9:00 AM to 11:00 AM at Wall Township Police Department, 2700 Allaire Rd, Wall, NJ 07719. An attempt to start vehicles engines will commence between 10:00 A.M. and 11:00 A.M.; and

WHEREAS, the Division of Local Government Services has approved Internet-based vendors for online auctions of surplus personal property. One of those vendors being used for online auction is usgovbid.com; and

WHEREAS, the Township of Wall has previously adopted Resolution No. 14-1113, which authorized the Public Auction Sale of various items; authorizing municipalities to use online auctions without DCA approval and without going out to bid

BE IT FURTHER RESOLVED, that the Township Clerk be and is hereby authorized to cause public notice of the aforesaid auction sale, to be published pursuant to N.J.S.A. 40A:11-36, in The Coast Star.


