WHEREAS, the Township Committee wishes to acquire a 2022 Ford F-250 for the Water and Sewer Department within Public Works; and,



WHEREAS, the Township Administrator received a proposal from Beyer Ford through State Contact #88727, and recommends that the Township Committee authorize the purchase of a 2022 Ford F-250 for the Water and Sewer Department within Public Works in the total amount of \$45,527.00 (forty-five thousand five hundred twenty-seven dollars and zero cents).
