ORDINANCE NO. 42 – 2004**

**AN ORDINANCE TO FIX THE COMPENSATION OF OFFICERS AND EMPLOYEES OF THE  
TOWNSHIP OF WALL FOR THE YEAR 2005**

**BE IT ORDAINED BY THE TOWNSHIP OF WALL IN THE COUNTY OF MONMOUTH AND  
THE STATE OF NEW JERSEY AS FOLLOWS:**
