

TOWNSHIP OF WALL

ORDINANCE NO. 48 - 2001

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING CHAPTER IV, "ANIMAL CONTROL", ARTICLE 4-1, "LICENSING OF DOGS", SECTION 4-1.5, "FEE", OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977" AS AMENDED AND SUPPLEMENTED, PERTAINING TO THE LICENSING AND REGISTRATION OF DOGS.

BE IT ORDAINED by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey as follows:

Section 1. Chapter IV, "Animal Control", Article 4-1, "Licensing of Dogs" of "The Revised General Ordinances of the Township of Wall, 1977" as amended and supplemented, be and the same is hereby further amended and supplemented by the deletion therefrom of Section 4-1.5, "Fee", and the substitution therefor of the following:

"4-1.5 Fee.

a. The person applying for the license shall pay to the township clerk the sum of twelve (\$12.00) dollars for the licensing and registration of each spayed dog and fifteen (\$15.00) dollars for the licensing and registration of each non-spayed dog.

b. Each license and tag shall be renewed annually and for each annual renewal the person applying shall pay the fee for the license and registration as hereinabove provided. For each license tag renewed on or before January 31 of the year of issuance, the fee for a spayed dog shall be reduced to seven (\$7.00) dollars and for the licensing and registration of each non-spayed dog, ten (\$10.00) dollars.

c. The licensing year shall run from January 31 of the year of issuance to January 31 of the following year."

Section 2. All ordinances, or parts thereof, inconsistent with the provisions of

this ordinance be and the same are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause, or any other portion of this ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this ordinance.

Section 4. This Ordinance shall become effective immediately upon its passage and publication according to law.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on November 28, 2001, and will be further considered for final passage and adoption at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on December 12, 2001, at 8:00 p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall, Town Hall, to the members of the general public who shall request the same.
