

TOWNSHIP OF WALL**ORDINANCE NO. 21 - 1999**

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING SCHEDULE III, "NO STOPPING OR STANDING," OF SECTION 7-3.5 "STOPPING OR STANDING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS," OF CHAPTER VII, "TRAFFIC," OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977," AS AMENDED AND SUPPLEMENTED, PERTAINING TO A NO STOPPING OR STANDING PROHIBITION ON ROUTES 70, 71, 34, 35 & 18 WITHIN THE CORPORATE BOUNDRIES OF THE TOWNSHIP OF WALL.

WHEREAS, "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, Section 7-3.5, "Parking or Standing Prohibited During Certain Hours on Certain Streets", provides that "[N]o person shall stop or stand a vehicle between the hours specified on Schedule III of any day (except Sundays and public holidays) on any of the streets or parts or streets described in Schedule III attached hereto and made a part of this Chapter"; and

WHEREAS, the Police Department in correspondence dated June 11, 1999 has recommended additions to the street schedule in Schedule III;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall as follows:

Section 1. Chapter VII, "Traffic", Section 7-3.5 "Stopping or Standing Prohibited During Certain Hours on Certain Streets", Schedule III, "No Stopping or Standing", be and the same is hereby further amended and supplemented by addition thereto of the following:

"Route 70	The entire length of the highway inclusive of all ramps and connections on both sides of the road within the corporate boundry of the Township of Wall.	Anytime
Route 71	The entire length of the highway inclusive of all ramps and connections on both sides of the road within the corporate boundary of the Township of Wall.	Anytime
Route 34	The entire length of the highway inclusive of all ramps and connections on both sides of the road within the corporate boundry of the Township of Wall.	Anytime
Route 35	The entire length of the highway inclusive of all ramps and connections on both sides of the road within the corporate boundry of the Township of Wall.	Anytime
Route 18	The entire length of the highway inclusive of all ramps and connections on both sides of the road within the corporate boundry of the Township of Wall.	Anytime"
