

**TOWNSHIP OF WALL**

**ORDINANCE NO. 6 - 1999**

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING SCHEDULE XIII, "NO LEFT TURN", OF SECTION 7-10.1, "LEFT TURN PROHIBITIONS", OF CHAPTER VIII, "TRAFFIC" OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977", AS AMENDED AND SUPPLEMENTED.**

**WHEREAS**, The Revised General Ordinances of the Township of Wall, 1977, as amended and supplemented, Section 7-10.1, provides that no person shall make a left turn at any of the locations described in Schedule XIII attached to and made a part of part of this Chapter;

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL** as follows:

Section 1. Chapter XIII, "Traffic", Section 7-10.1, "Left Turn Prohibitions", Schedule XIII, "No Left Turn", of "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, be and is hereby further amended and supplemented by the addition thereto of the following locations at which a left turn is prohibited:

<u>LOCATION</u>	<u>DIRECTION</u>	<u>PROHIBITED</u>
"Allaire Road and driveway entrance to Block 741, Lot 16	Eastbound on Allaire Road	No left turn
Driveway exit from Block 741, Lot 16 to Allaire Road	Eastbound on Allaire Road	No left turn"

Section 2. All ordinances, or parts thereof, inconsistent with the provisions of this ordinance be and the same are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause, or any other portion of this ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this ordinance.

Section 4. This Ordinance shall become effective immediately upon its passage and publication according to law and upon the filing of a certified copy thereof with the Monmouth County Planning Board.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on February 10, 1999 and will be further considered for final passage and adoption at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on March 10, 1999 at 8:00 p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall, Town Hall, to the members of the general public who shall request the same.
