

TOWNSHIP OF WALL
ORDINANCE NO. 2 - 1998

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SCHEDULE VII, "THROUGH STREETS," OF SECTION 7-6.1, "THROUGH STREETS," OF CHAPTER VII, "TRAFFIC," OF "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977," AS AMENDED AND SUPPLEMENTED.

WHEREAS, Section 7-6.1, entitled "Through Streets", of Chapter VII, "Traffic", of "The Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, provides in pertinent part that: "[T]he streets or parts of streets described in Schedule VII attached to and made a part of this Chapter are hereby designated as Through Streets"; and

WHEREAS, after a field investigation and an on-site review, it has been determined by the Police Department and the New Jersey Department of Transportation, Bureau of Traffic and Engineering Safety Programs, that there are several roadways in the Township that should be designated as "Through Streets," with appropriate STOP signs to be erected on the near right side of each street intersecting with the said Through Streets, except where Yield signs are provided for in the designation, in accordance with the provisions of Section 7-6.1 and N.J.S.A. 39:4-140; and

WHEREAS, the Township Committee now wishes to amend and supplement Schedule VII in order to effectuate the designation of these new Through Streets;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey, as follows:

Section 1. Schedule VII, "Through Streets", of Section 7-6.1, "Through Streets", of Chapter VII, "Traffic", of "The Revised General Ordinances of the Township of Wall, 1977," as amended and supplemented, is hereby further amended and supplemented in order to designate the following roadways, or part of roadways, as Through Streets within the Township, with appropriate STOP signs to be erected on the near right side of each street intersecting with the said Through Streets:

- A. "CLEVELAND AVENUE:
Between Belmar Boulevard (County Road 18) and Pierce Street. "
- B. "WASHINGTON AVENUE:
Between Belmar Boulevard (County Road 18) and Buchanan Street."

Section 2. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

Section 4. This Ordinance shall take effect upon its passage and publication according to law, but not before approval of the same by the Commissioner of the New Jersey Department of Transportation.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on January 14, 1998 and will further be considered for final passage and adopted at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on February 11,

1998 at 8:00 o'clock p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's Office in the Township of Wall Town Hall to the members of the general public who shall request the same.
