

TOWNSHIP OF WALL
ORDINANCE NO. 14 - 1997

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SCHEDULE V, "TRUCKS OVER FOUR TONS," OF SECTION 7-4.1, "TRUCKS OVER FOUR TONS EXCLUDED FROM CERTAIN STREETS," OF CHAPTER VII, "TRAFFIC," OF THE "REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977" AS AMENDED AND SUPPLEMENTED.

WHEREAS, Section 7-4.1, entitled "Trucks Over Four Tons Excluded From Certain Streets," of Chapter VII, "Traffic," of the "Revised General Ordinances of the Township of Wall, 1977", as amended and supplemented, provides in pertinent part that: "Trucks over four tons gross weight are hereby excluded from the streets or parts of streets described in Schedule V except for pick up and delivery of materials"; and

WHEREAS, after a field investigation and an on-site review, it has been determined by the New Jersey Department of Transportation, Bureau of Traffic and Engineering Safety Programs, that there are several roadways in the immediate vicinity of the intersection of Route 34 and Lakewood Road of the Township that should be designated as streets that should be included under Schedule V, "Trucks Over Four Tons," with appropriate signs to be erected on the near right side of each street, in accordance with the provisions of Section 7-4.1; and

WHEREAS, the Police Department has recommended an addition to the streets included in Schedule V; and

WHEREAS, the Township Committee now wishes to amend and supplement

Schedule V in order to effectuate the designation of these new limitations.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey, as follows:

Section 1. Schedule V, "Trucks Over Four Tons," of Section 7-4.1, "Trucks Over Four Tons Excluded From Certain Streets," of Chapter VII, "Traffic," of the "Revised General Ordinances of the Township of Wall, 1977," as amended and supplemented, is hereby further amended and supplemented in order to include the following roadways, or part of roadways, as part of the four-ton truck weight limitation schedule, within the Township, with appropriate signs to be erected on the near right side of each street:

<u>Name Of Street</u>	<u>Location</u>
"Ramshorn Drive	Between Old Bridge Road and Atlantic Avenue
Lakewood Road	From a point 95 feet west of the westerly curblineline of Route 34 to Ramshorn Drive
Holly Boulevard	Between Route 34 and Ramshorn Drive
Paynters Road	From a point 115 feet west of the westerly curblineline of Route 34 to Ramshorn Drive."

Section 2. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 3. Should any section, paragraph, clause or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such

judgment shall not affect or impair the remainder of this Ordinance.

Section 4. This Ordinance shall take effect upon its passage and publication according to law, but not before approval of the same by the Commissioner of the New Jersey Department of Transportation.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on July 9, 1997 and will further be considered for final passage and adopted at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on July 23, 1997 at 8:00 o'clock p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Clerk's Office in the Township of Wall Town Hall to the members of the general public who shall request the same.
