

**TOWNSHIP OF WALL  
ORDINANCE NO. 7 - 1997**

**ORDINANCE PROVIDING FOR THE REVISION AND PREPARATION OF A MASTER PLAN AND AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION IN THE AMOUNT OF \$100,000 THEREFOR, AUTHORIZED IN AND BY THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, NEW JERSEY**

**WHEREAS**, the Township of Wall, in the County of Monmouth, New Jersey (the "Township") has determined to revise and prepare the Master Plan of the Township; and

**WHEREAS**, no budget appropriation will be included in the local budget for the Township for the year 1997 for such purposes; and

**WHEREAS**, the cost of the same is estimated at the sum of \$100,000.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Wall, in the County of Monmouth, State of New Jersey, (not less than a majority of the members thereof affirmatively concurring), as follows:

Section 1. Pursuant to N.J.S.A. 40A:4-53(d) of the Local Budget Law (constituting Chapter 4 of Title 40A of the New Jersey Statutes), the sum of \$100,000 is hereby appropriated and shall be deemed a special emergency appropriation for the revision and preparation of the Master Plan of the Township.

Section 2. Said special emergency appropriation shall be provided for in succeeding annual budgets by the inclusion of at least one-fifth (1/5) of said amount each such year, commencing in 1998, and shall be financed from surplus funds available or from the issuance of special emergency notes, as authorized by separate resolution adopted pursuant to N.J.S.A. 40A:4-55.

Section 3. This ordinance shall take effect immediately upon its passage,

approval and publication as provided by law.

### NOTICE

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on March 12, 1997, and will be further considered for final passage and adoption at the South Wall Firehouse, Atlantic Avenue, Wall, New Jersey on March 26, 1997 at 8:00 p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said ordinance will be made available at the Clerk's Office in the Township of Wall Town Hall to the members of the general public who shall request the same. A copy of this Ordinance has been posted on the bulletin board upon which public notices are customarily posted in the Municipal Building of the Township during the week prior to and up to and including the date of such meeting.
