

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING CHAPTER VII, "TRAFFIC", "THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WALL, 1977", AS AMENDED AND SUPPLEMENTED, SECTIONS 7-11 "SPEED LIMITS" AND 7-16, "NO PASSING ZONES".

WHEREAS, the Township has performed the necessary speed surveys and investigations required for establishing speed limits and no passing zones; and

WHEREAS, the Department of Transportation of the State of New Jersey has authorized the Township to set speed limits on Tilton's Corner Road, Algonkin Trail, and Wyckoff Road and to establish no passing zones on Allenwood Road;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall, County of Monmouth, State of New Jersey as follows:

Section 1. Chapter VII, "Traffic" of "The Revised General Ordinances of the Township of Wall, 1977" as amended and supplemented, Schedule XVI "Speed Limits", is hereby amended and supplemented as follows:

A. Tilton's Corner Road:

40 MPH entire length

B. Algonkin Trail:

25 MPH entire length

C. Wyckoff Road:

40 MPH between Belmar Blvd. and 510 ft. south of Megill Road.

30 MPH between 510 ft. south of Megill Road and 690 ft. north of Megill Road.

40 MPH between 690 ft. north of Megill Road and

NJ Route 34.

Section 2. Chapter VII, "Traffic" of "The Revised General Ordinances of the Township of Wall, 1977" as amended and supplemented, Schedule XVIII "No Passing Zone", is hereby supplemented by the addition of the following:

NAME OF STREET	DIRECTION	LOCATION
Allaire Rd.	Both Directions	From Allaire Rd. - Ridgewood Rd. to Gulley Rd.

Section 3. All Ordinances, or parts thereof, inconsistent with the provisions of this Ordinance, be and the same are hereby repealed to the extent of such inconsistency.

Section 4. Should any section, paragraph, clause or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgement shall not affect or impair the remainder of this Ordinance.

Section 5. This Ordinance shall take effect immediately upon its passage and publication according to law.

Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading by the Township Committee of the Township of Wall on *Oct. 26, 1993* and will be further considered for final passage and adoption at the Wall Township Municipal Building, 2700 Allaire Road, Wall, New Jersey, on *Nov. 9, 1993* at 8 o'clock p.m., or as soon thereafter as the matter can be reached on the agenda, at which time and place all persons interested therein shall be given an opportunity to be heard, and during the week prior to, and up to and including, the date of such meeting, copies of said Ordinance will be made available at the Clerk's office in the Township of Wall Town Hall to the members of the general public who shall request the same.
