

TOWNSHIP OF WALL

ORDINANCE NO. 43 - 1990

AN ORDINANCE OF THE TOWNSHIP OF WALL CHANGING THE NAME OF "MUNICIPAL COURT" TO "BEDFORD CORNER LANE".

WHEREAS, the Township's Municipal Building is no longer located on the street currently known as "Municipal Court", and the Township Committee has received a request from the residents of Municipal Court to change the name of that street; and

WHEREAS, pursuant to N.J.S.A. 40:67-1, the Township Committee is empowered to adopt an Ordinance establishing or changing the names of streets within the Township;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall, in the County of Monmouth and State of New Jersey, as follows:

Section 1. The name of the public street currently known as "Municipal Court", which lies between New Bedford Road and Belmar Boulevard, be and the same is hereby changed to "Bedford Corner Lane".

Section 2. This Ordinance shall take effect immediately upon its passage and publication according to law.

Section 3. All Ordinances, or parts, thereof, inconsistent with the provisions of this Ordinance, be and the same are hereby repealed to the extent of such inconsistency.

Section 4. Should any section, paragraph, clause or any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or

impair the remainder of this Ordinance.

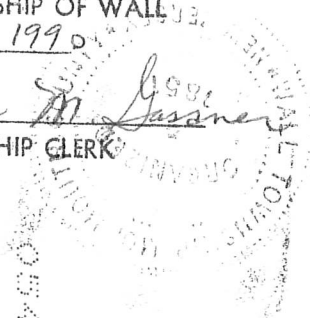
NOTICE
