RESOLUTION NO. 22-0925

AUTHORIZATION TO AWARD A CONTRACT TO CJ HESS, INC. FOR THE MUNICIPAL COMPLEX PARKING LOT EXPANSION PROJECT IN THE AMOUNT OF \$771,019.62

WHEREAS, pursuant to N.J.S.A. 40A:11-5 et seq., the Local Public Contract Law, the Township Committee previously authorized the advertisement for the receipt of bids for the municipal complex parking lot expansion project; and,



WHEREAS, on September 15, 2022, the Township received seven (7) bid proposals, which are identified as follows:

CJ Hess, Inc	\$771,019.62 (seven hundred seventy-one thousand nineteen dollars and sixty-two cents)
Shore Top Construction Corp.	\$786,882.00 (seven hundred eighty-six thousand eight hundred eighty-two dollars and zero cents)
Earl Asphalt Company	\$787,113.13 (seven hundred eighty-seven thousand one hundred thirteen dollars and thirteen cents)
Black Rock Enterprises	\$839,263.10 (eight hundred thirty-nine thousand two hundred sixty-three dollars and ten cents)
Seacoast Construction, Inc.	\$872,577.30 (eight hundred seventy-two thousand five hundred seventy-seven dollars and thirty cents)
Meco, Inc.	\$945,003.50 (nine hundred forty-five thousand three dollars and fifty cents)
James R. Ientile, Inc.	\$998,999.00 (nine hundred ninety-eight thousand nine hundred ninety-nine dollars and zero cents)

WHEREAS, the Township Attorney reviewed the bids received for legal sufficiency and the Township Engineer reviewed said bids and recommends that the contract be awarded to CJ Hess Inc.; and,
