ORDINANCE AMENDING CHAPTER 161 OF THE CODE OF THE TOWNSHIP OF WALL ENTITLED HOURS OF OPERATION FOR PARKS, PLAYGROUNDS AND RECREATION AREAS

WHEREAS, the Township of Wall regulates the activities and hours of operation within the parks and recreation areas of the Township of Wall, by and through Chapter 161 of the code of the Township of Wall; and

WHEREAS, Chief of Police, David Morris has recommended an amendment to Chapter 161 in the interest of public safety and general welfare, to change the hours of operation within the parks and recreation areas of the Township of Wall; and

WHEREAS, the Township Committee concurs with the recommendations of Chief Morris and is desirous of amending Chapter 161 to change the hours of operation within the parks and recreation areas of the Township of Wall.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall as follows:

SECTION ONE

Chapter 161-1A of the Code of the Township of Wall entitled "Hours stated; occupation after hours prohibited" is hereby amended as follows:

Chapter 161-2A of the Code of the Township of Wall entitled "Exception for recognized organizations"; permit is hereby amended as follows:
