COUNTY OF MONMOUTH TOWNSHIP OF WALL ORDINANCE NO. 17-2011 AS AMENDED

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL AMENDING AND SUPPLEMENTING CHAPTER 215 OF THE CODE OF THE TOWNSHIP OF WALL ENTITLED VEHICLES AND TRAFFIC PERTAINING TO GROSS VEHICLE WEIGHT RATING

WHEREAS, the Township of Wall is desirous of amending Chapter 215 of the Code of the Township of Wall entitled Vehicles and Traffic pertaining to Gross Vehicle Weight Rating; and

WHEREAS, the Director of Engineering and Planning in conjunction with the Police Department has recommended to the Township Committee that the Gross Vehicle Weight Rating allowed on township streets or parts of streets be amended; and

WHEREAS, the Township Committee finds that this amendment would be beneficial to the Township and its residents.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wall as follows:

SECTION ONE

Section 215-10 is hereby deleted and replaced with the following:

§215-10 – <u>Trucks over 8,000 lbs. GVWR (Gross Vehicle Weight Rating) excluded from certain streets.</u>

Trucks over 8,000 lbs. GVWR (Gross Vehicle Weight Rating) are hereby excluded from the streets or parts of streets described in Schedule V except for the pickup and delivery of materials on such streets. Schedule V being attached to and made a part of this chapter.

SECTION TWO

§215-37 – <u>SCHEDULE V: Trucks over 8,000 lbs. GVWR (Gross Vehicle Weight</u>

Rating)

In accordance with the provisions of 215-10, trucks over 8,000 lbs. GVWR (Gross Vehicle Weight Rating) are excluded from the following described streets or parts of streets:

(Street descriptions to remain the same as existing Ordinance at this time.)

SECTION THREE

If any part of this Ordinance shall be deemed invalid by an administrative agency or court of competent jurisdiction, such decision shall not affect the legality and enforceability of any other provision hereof.

SECTION FOUR

All ordinances, policies and or procedures or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency.

SECTION FIVE
