RESOLUTION NO. 20-0150

AUTHORIZING EXECUTION OF A CONTRACT WITH ASSOCIATED HUMANE SOCIETIES, INC. TO SERVE AS ANIMAL CONTROL OFFICER FOR WALL TOWNSHIP FOR THE PERIOD JANUARY 1, 2020 THROUGH DECEMBER 31, 2020 IN AN AMOUNT NOT TO EXCEED \$62,952.00

WHEREAS, pursuant to N.J.S.A. 4:19-15 et. seq. each municipality in New Jersey is required to appoint an animal control officer (ACO) for the purpose of providing rescue and recovery of injured animals; and,

WHEREAS, the Township of Wall researched the various options it has with regard to appointment of an ACO and has determined that this position shall be filled by the appointment of the Associated Humane Societies, Inc. to serve in this capacity from January 1, 2020 through December 31, 2020 at a contract amount not to exceed \$62,952.00; and,


WHEREAS, the Township of Wall is hereby authorized to contract with the Associated Humane Societies, Inc. to serve as Wall Township's ACO for 2020; and,

WHEREAS, the Township's Board of Health Attorney reviewed the proposed contract and found the same to be legally sufficient; and,

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wall as follows:

1. The Township Committee hereby authorizes execution of a contract with Associated Humane Societies, Inc. to provide ACO services for 2020 at an amount not to exceed \$62,952.00.
2. This resolution is subject to the filing of certification from the CFO as to the availability of funds per N.J.A.C. 5:30-5.3 (a).
3. The Mayor, Municipal Clerk, and any other applicable Township officers or employees are hereby authorized and directed to take such ministerial actions as are necessary to effectuate the terms of this resolution.


